Dear Mr. Allen and Ms. Rapien:

I handle the sexual offense cases that come through the Juvenile Court. While working on these cases, I frequently work with both Rob Dziech and Kathryn Avena. I wanted to bring to your attention a specific case involving both of those individuals. A young man was charged with two misdemeanor Theft offenses involving the stealing of some books. While Mr. Dziech was reviewing the case, he noticed the case involved some serious sexual problems relating to this young man. I appreciate that Mr. Dziech cared enough to put forth the effort in realizing this case needed some special attention, and was just not a regular Theft offense. Mr. Dziech contacted Ms. Avena who also recognized that this young man had some serious sexually related problems. Ms. Avena, like Mr. Dziech, realized what a danger this young man could be in the community should he not receive the appropriate treatment for his sexual offending thoughts.

Ms. Avena contacted me, which led to a Probation Investigation being conducted. During my investigation, it was discovered that this young man had very serious thoughts about sexually molesting young children. The young man went so far to admit he had his victim already picked out, and the time and place to which he planned on molesting his own 10



year old male cousin. Further investigation and after several clinical evaluations, it was discovered how very deep-seated this young man's thoughts of sexually molesting other children had become. Thanks to the wonderful efforts of Mr. Dziech and Ms. Avena, this 10-year-old boy did not become a victim, and quite possibly, prevented several other children from becoming victims. The young man in question is now being placed into a residential treatment facility which will address his sexually offensive issues. The wonderful efforts by Mr. Dziech and Ms. Avena are nothing out of the ordinary that I see from them everyday; however, the fact that everyone was proactive in preventing a serious crime instead of having to react to it after the fact, makes this case stand out in my mind. The Prosecutor's Office should be very proud to be represented by two dedicated and hard working individuals as Rob Dziech and Kathryn Avena.
